Which Medicare payment systems cover Holter services?

Holter is covered by both the Physician Fee Schedule (PFS) and the Hospital Outpatient Payment System (OPPS). PFS pays for office-based costs of testing, while OPPS pays for the hospital costs of outpatient testing. Physician work is billed to the PFS in either scenario.
